- Introduction of Rules / Speaker by Alexander Granados
- Kristi Day (Director of the Office of Academic Standards) Presentation on Standards Review and Revision Process
 - Question/Welcoming: What do you think of when you hear the word 'standards'?
 - o Difference Between Standards, Curriculum, and Instruction
 - Standards: North Carolina Standard Course of Study
 - Curriculum (How something gets to the Classroom): Texts, Lesson Plans, Activities, Tasks, Classroom Assessments
 - Instruction (What happens in the Classroom): Delivery of the Curriculum;
 Approaches; Strategies; Differentiation
 - o Office of Academic Standards
 - Kelly Schultz Standards Implementation Specialist
 - Math, Science, and STEM (but no STEM Standards at this moment).
 - Social Studies & Arts Education
 - NC Healthy Schools
 - ELA & Languages
 - Experts in the field write the standards, we just follow those recommendations.
 Also focuses heavily on professional development and teacher training.
 - General Statute 115C
 - Section 9c is the power to develop content standards that gives guidelines for standards as well as the power to create ones that are measurable.
 - 115C 81.5 is the Standard Course of Study
 - State Board Policy SCOS 012
 - NCDPI reviews each set of content standards every 5-7 years. Uses four guiding principles during review (On Slides)
 - NC Standard Course of Study shows the variety of courses that standards are drafted/reviewed.
 - o Internal Procedures Manual
 - Provides a definitive explanation of the process to be followed when developing or revising a section of the NCSCOS. Sent out with the PowerPoint.
 - State (SEA) vs. Local Responsibilities
 - Five comparisons listed on slide show
 - o Review, Revision, & Implementation 5-7 year cycle:
 - Review is normally 12 months
 - Revision is normally 12 months
 - Implementation is normally the last 3-4 years.
 - Standards Review Phase
 - Goes standard by standard, and objective by objective.
 - Regional Focus Groups with a new district focus (Teachers, Admins, District Leaders)
 - Interviews
 - DPI then does research across a minimum of 5 states and convenes a Data Review Committee. That committee is randomly created.

- Research & DRC Report is the final action item.
 - Research shows what to do but the DRC issues the final recommendations/revisions.
- Standards Revision Phase
 - Standards Writing Team (SWT)
 - They write it in this order primarily:
 - Draft, New or Modified Form, 'Based on', Criteria Addressed,
 Comments/Notes
 - First Draft with a Standard-by-Standard survey
 - Public Comment for 30 days
 - DRC Compiles feedback from the SWT
 - SWT creates second draft.
 - Public Comment for 30 days
 - **SWT Creates Third Draft for SBE**
- Format of Objectives
 - Subject is understood to be the Student
 - Verb (How the student will demonstrate their understanding) requires the learner to be able to show their knowledge
 - Object

- Update on Current Review and Revision Phases (These are currently in the process)
 - K-12 Science
 - May of 2022 received SBE Approval; June of 2023 presented to SBE for July 2023 approval. Installation in 2023-2024 school year. Initial Implementation is 24-25.
 - Major Changes:
 - Clarifying Language
 - Embedding Scientific & Engineering Practices
 - PD and Resource Support
 - Building Operational Assessments for 2024-2025 school year.
 - K-12 Healthful Living
 - Health and Physical Education

- May 2022 received SBE Approval; June 2023 Draft 1 presented to the SBE; Feedback surveys were sent on June 5 and will close September 18th
- Next Steps:
 - DRC will analyze data
 - SWT will revise and create Draft 2
 - Cycle Repeats
- Tentatively Spring 2024 approval
 - o Installation would be 2024-2025
 - Initial Implementation 2025-2026
- K-12 Arts
 - Dance, Music, Theatre Arts, Visual Arts
 - June 2023 received SBE approval
 - Draft 1 will be presented to SBE in Ocetober
 - Draft 3 tentatively scheduled for next Summer
 - Installation 24-25
 - o Implementation 25-26
- K-12 Guidance
 - June 2023 Received SBE Approval
 - DRC found that a lot of people recommended adopting the American School Counselor Association Mindsets and Behaviors
 - Survey for additional / specific data released week of June 5;
 Due Sept. 10
 - Tentative Dates:
 - If ASCA are adopted:
 - Installation 23-24
 - Implementation 24-25
 - o If Full revision process:
 - Installation 24-25
 - Implementation 25-26
- K-12 World Languages
 - June 2023 approval at SBE; Draft 1 presented to SBE in September.
 Survey will be released by mid-september.
 - If Approved Tentative Dates:
 - Installation 24-25
 - Implementation 25-26
- K-12 ELA
 - Kicked off Review Phase in April 2023
 - DRC applications released in October 2023
 - SBE permission to revise tentative in Spring 2024
- The goal is to have one in review and one in revision at all times (Get back on the 5-7 year plan).
 - Also so that there are not a bunch of standards being changed at one time.

- Question from Alex Granados
 - Answer; We can't just rush in and stick to one standard because we are constantly needing to look at the most up-to-date research to insure we have the best method moving forward.
- o Question from Committee Member
 - How do we compare to other states in the standards revision regard?
 - Answer: We are good in some, good in others. Science we were one of the last to update but in World Languages / ELA we are one of the first to update to certain standards. Common Core is another example of this.
