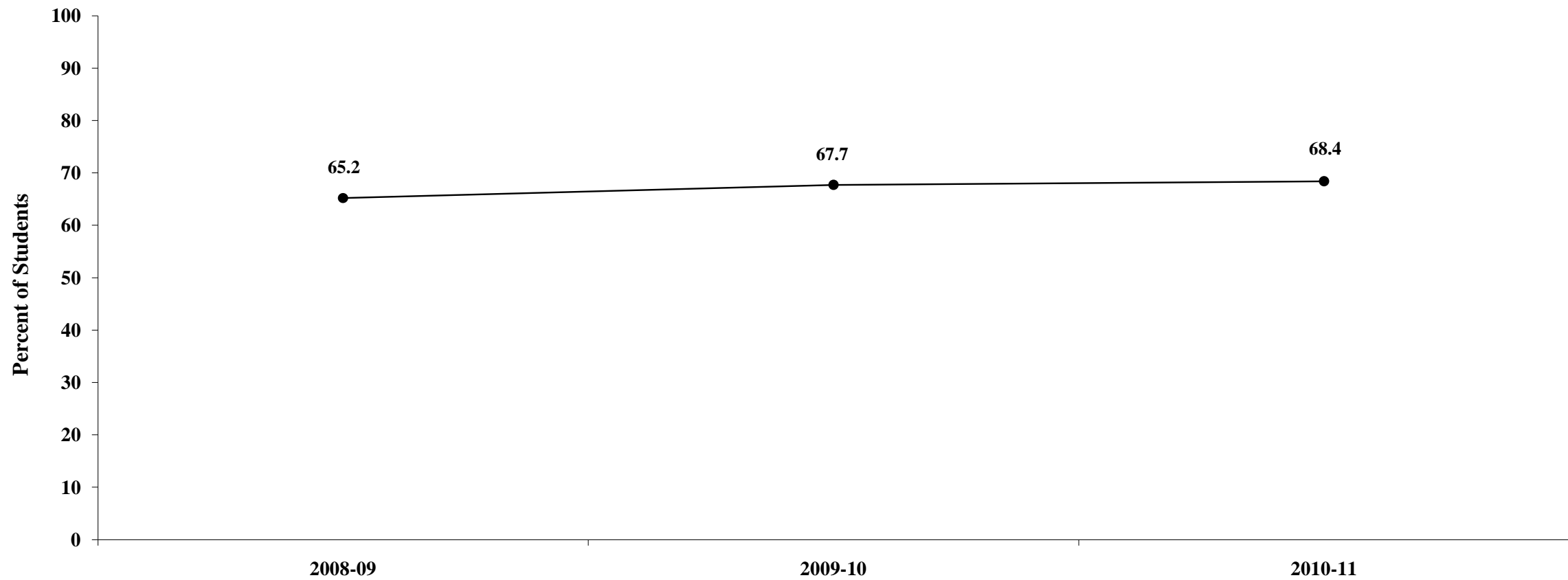


**Figure 1. 2008-09 to 2010-11 End-of-Grade General Test Multiple-Choice Test Results

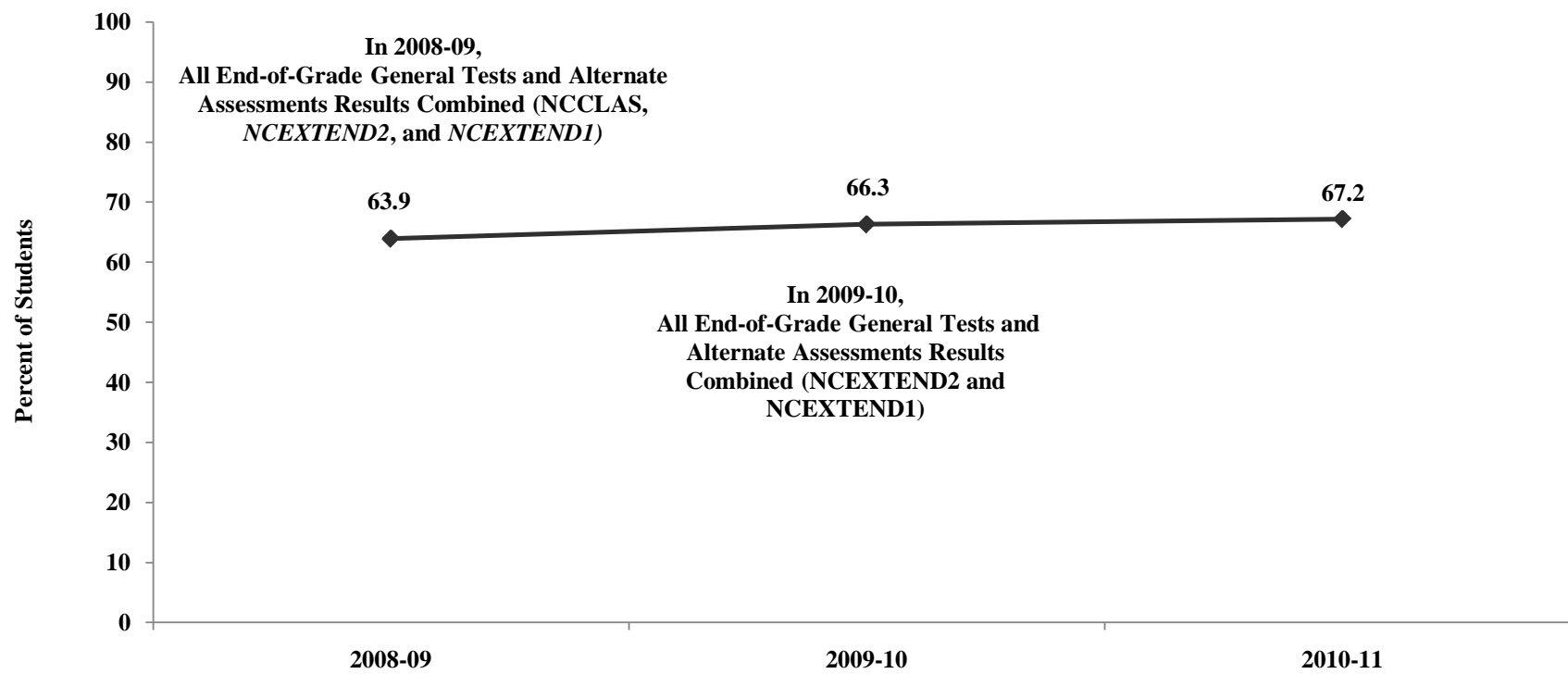

After Retests Grades 3-8, with Final Administration Scores

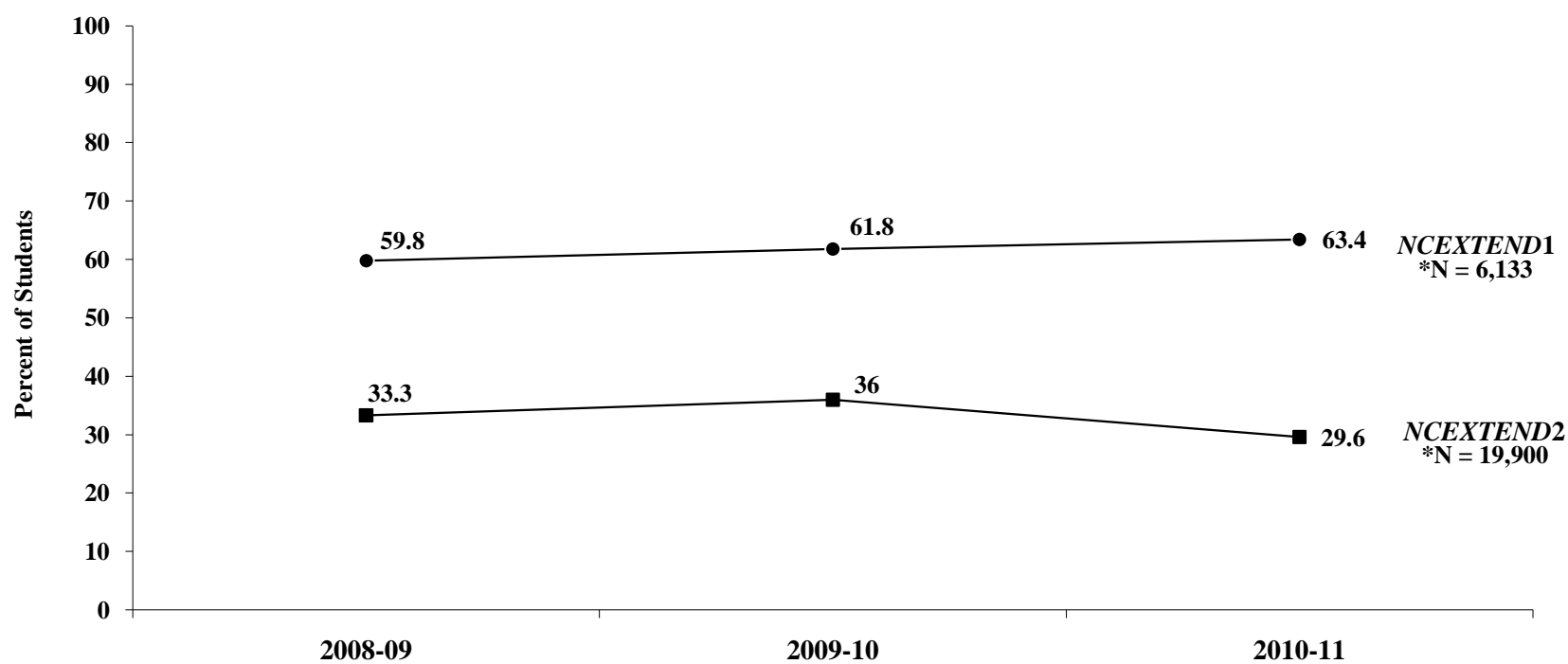

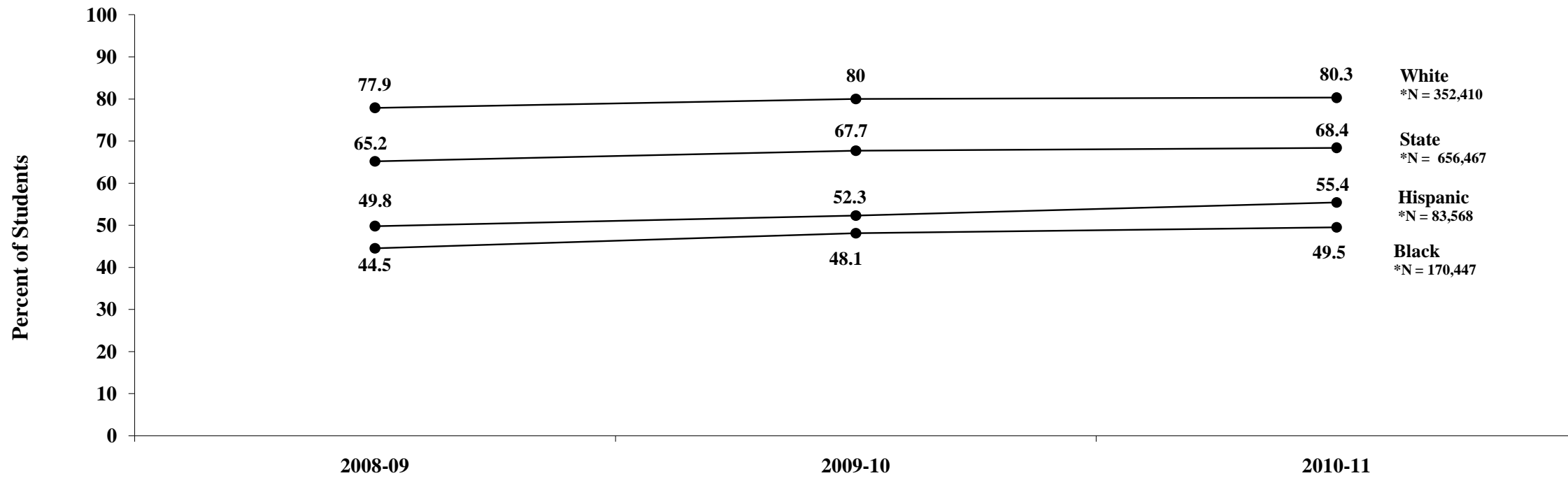

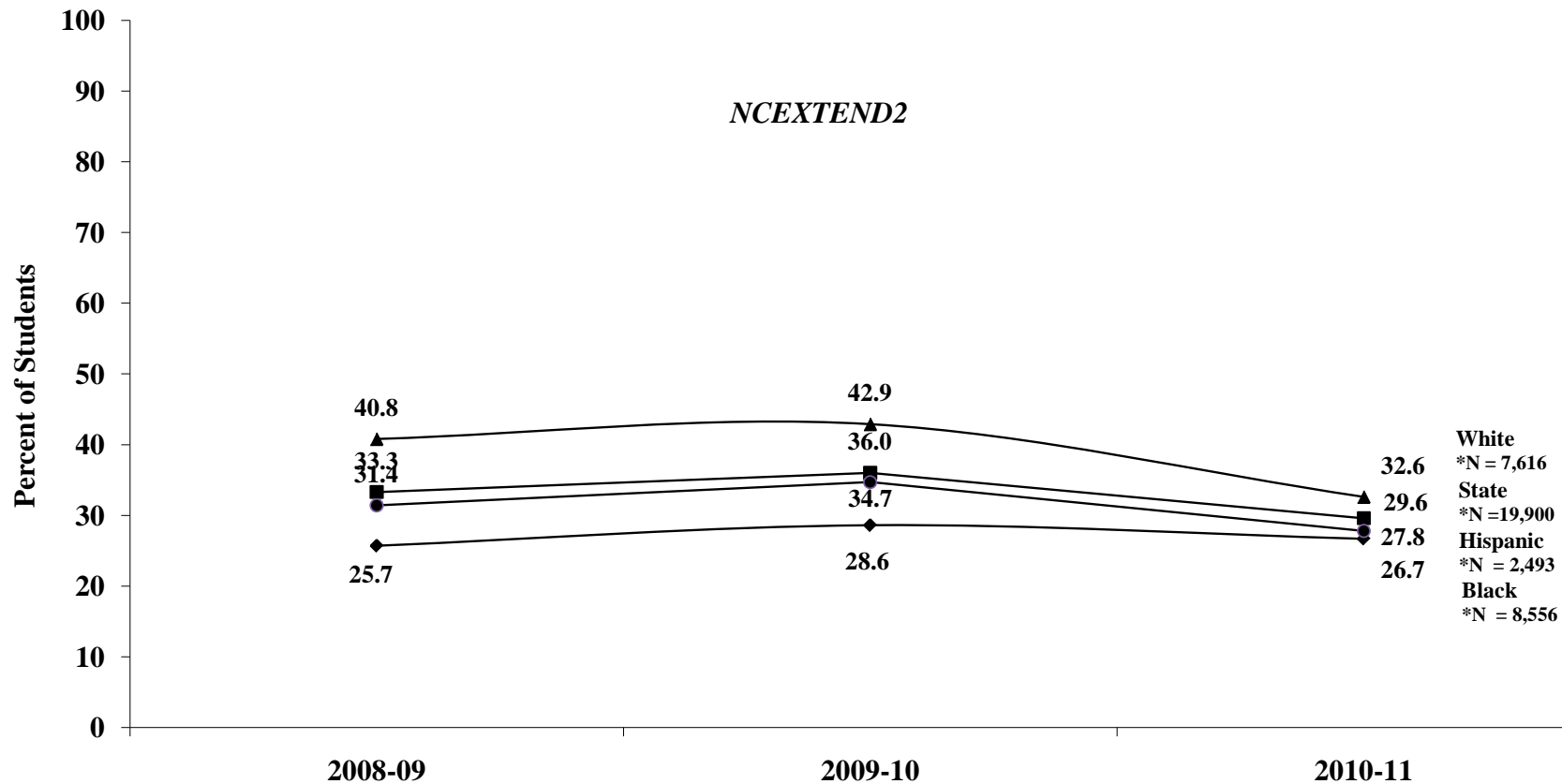

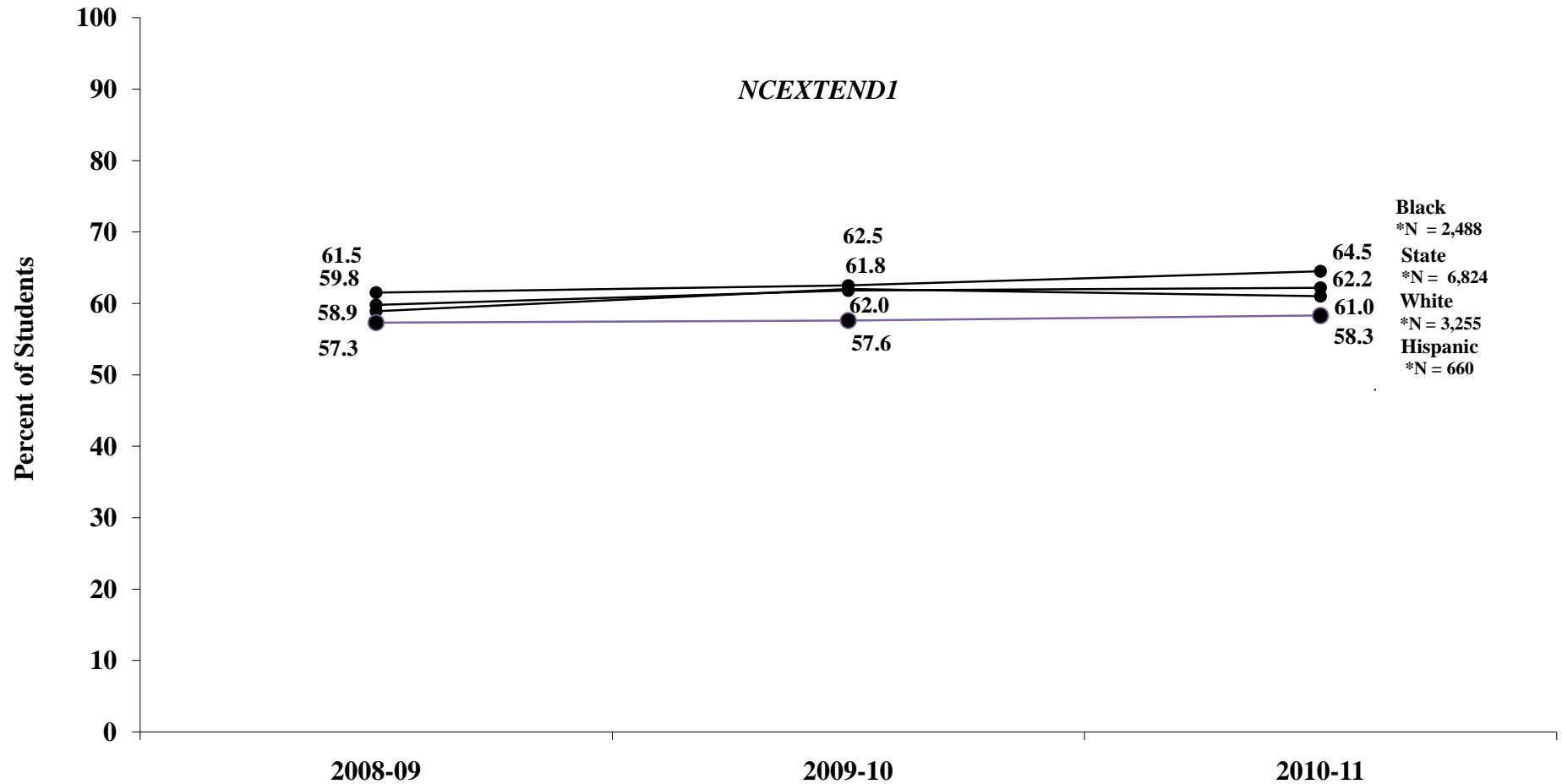

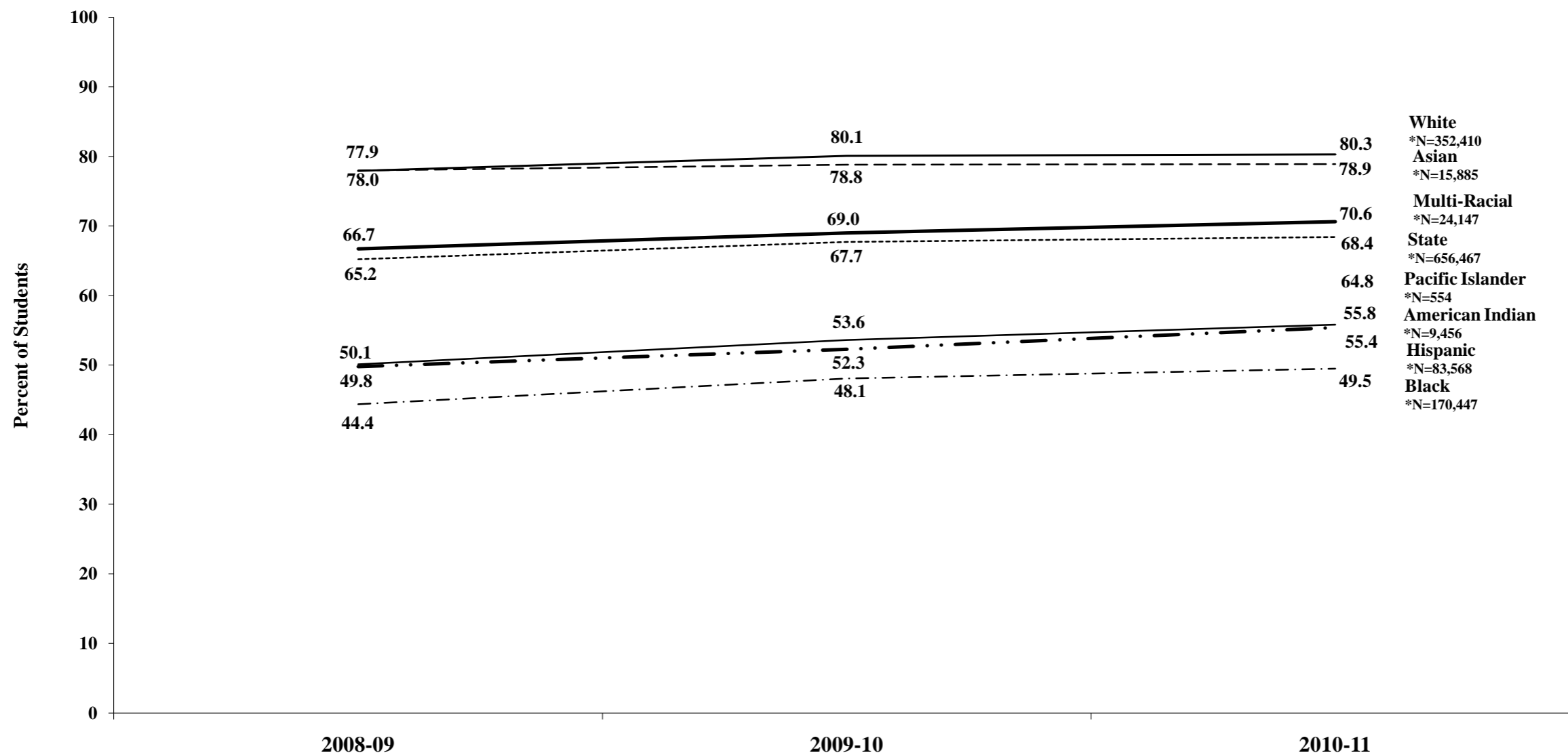

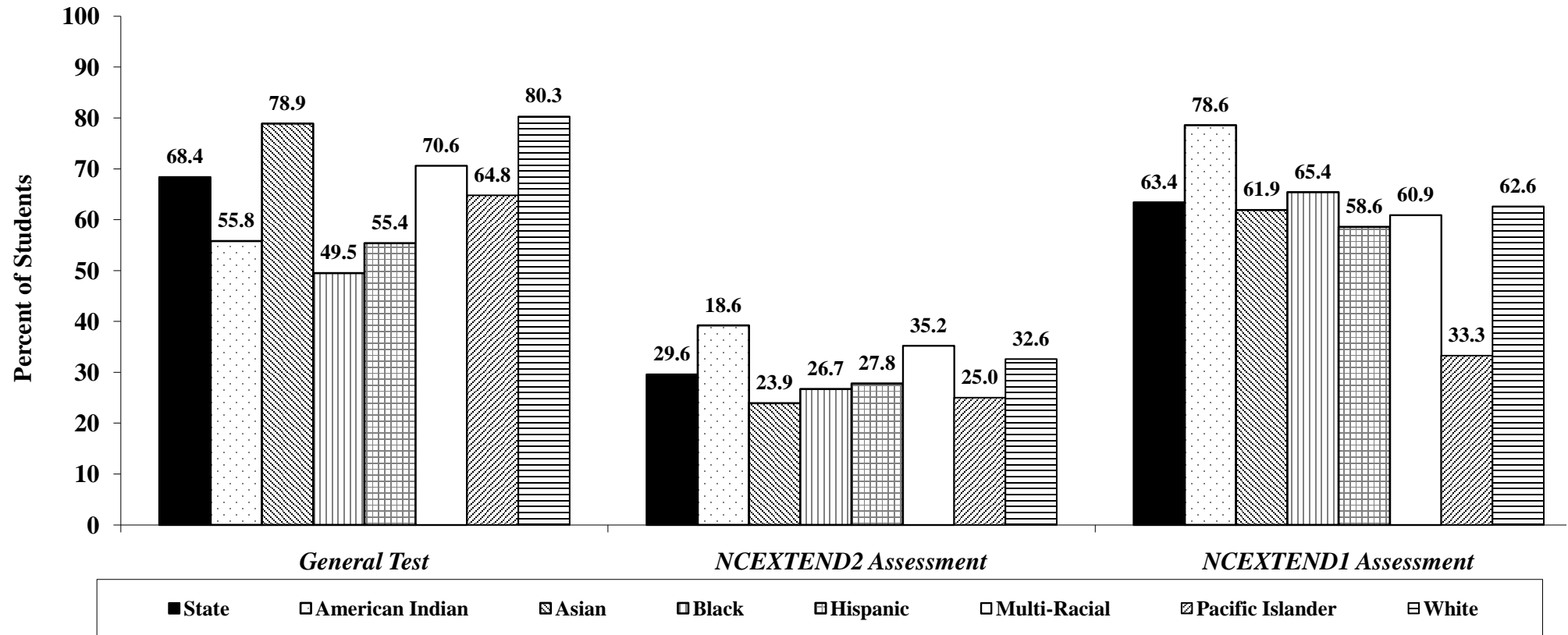

After Retests Grades 3-8, by Test Type and Ethnicity, with Final Administration Scores



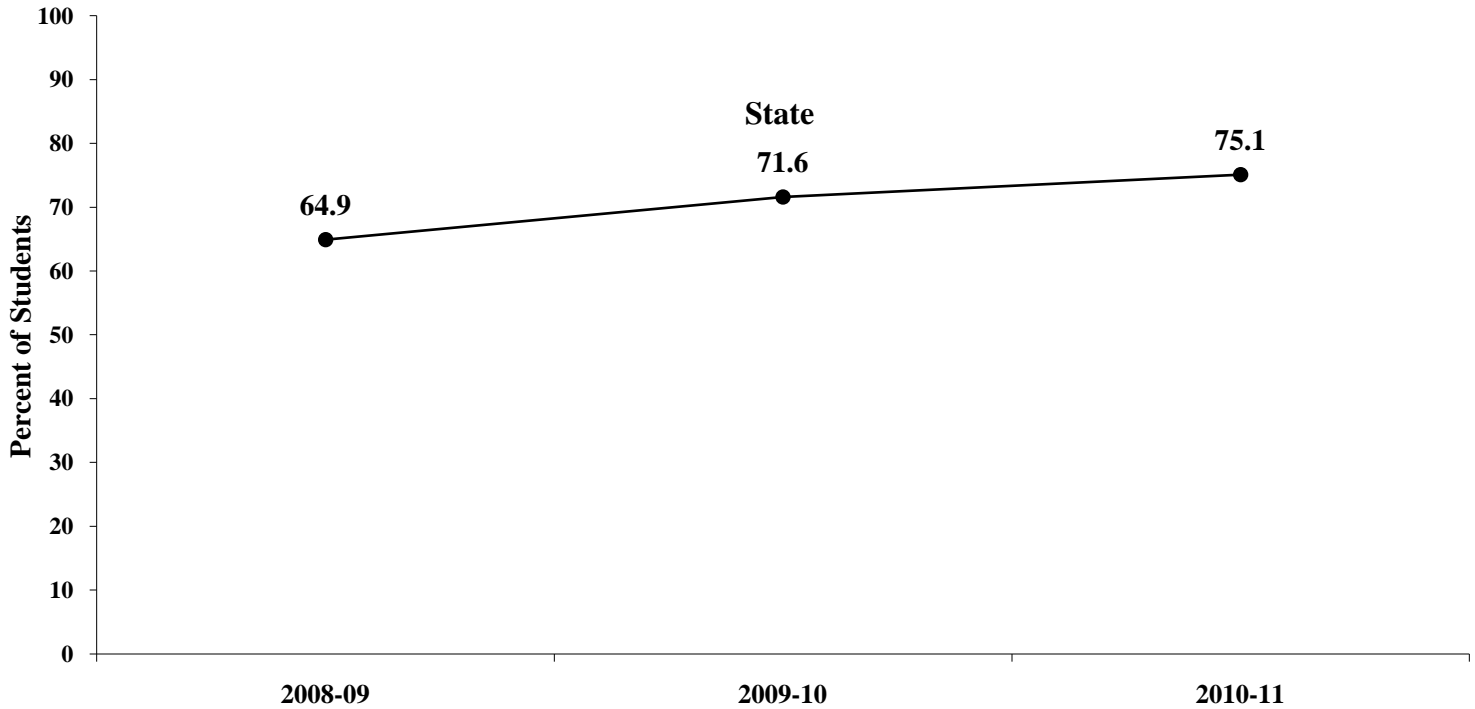

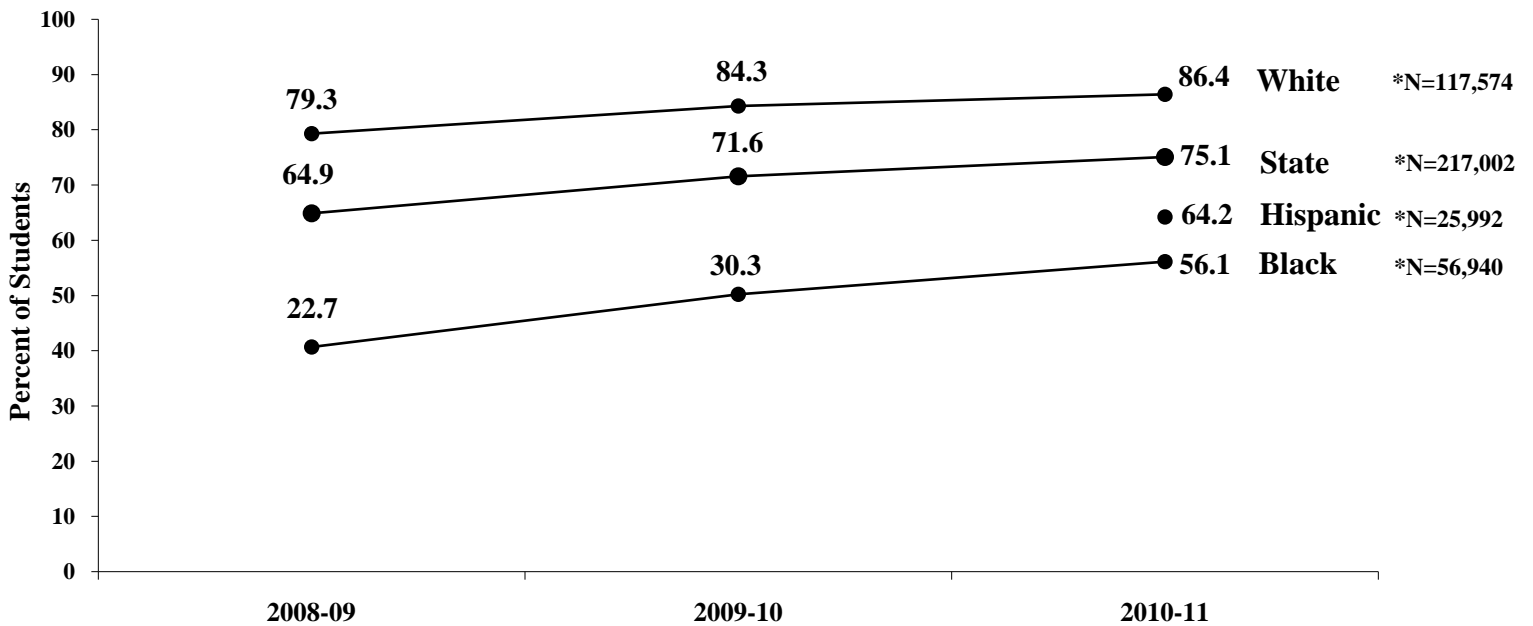

After Retests Grades 5 and 8 Combined, with Final Administration Scores**

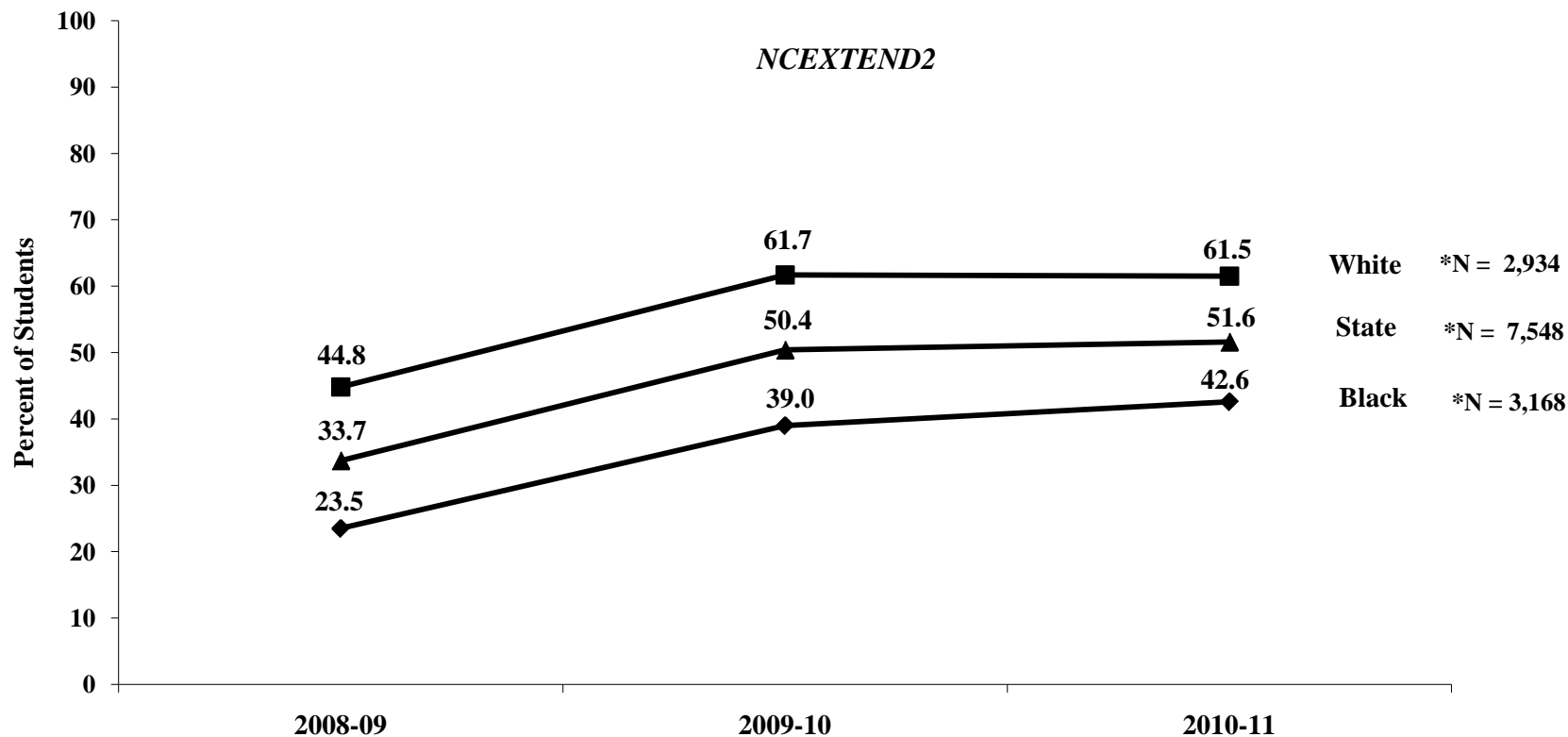


**Figure 5. 2008-09 to 2010-11 End-of-Grade General Test Multiple-Choice Test Results

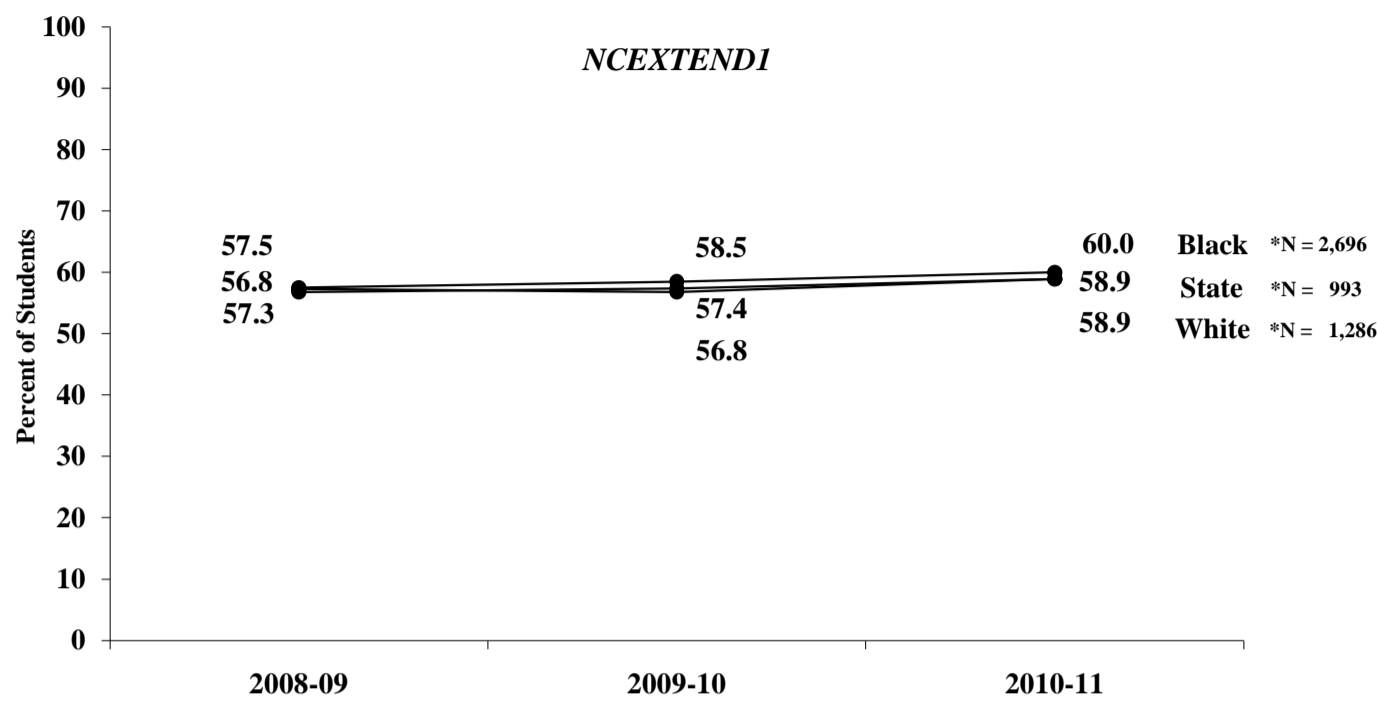

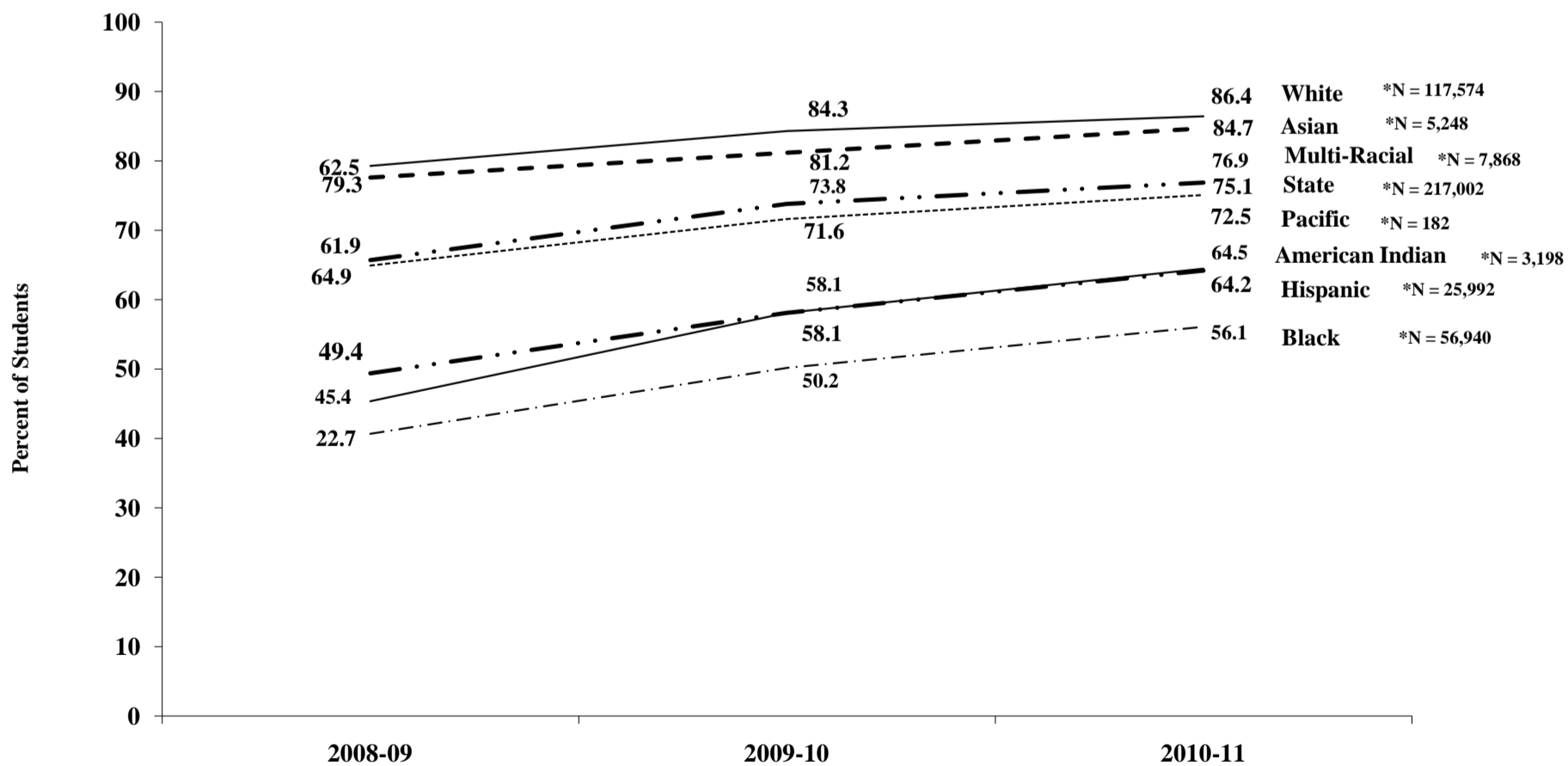

After Retests Grades 5 and 8 Combined, by Ethnicity, with Final Administration Scores



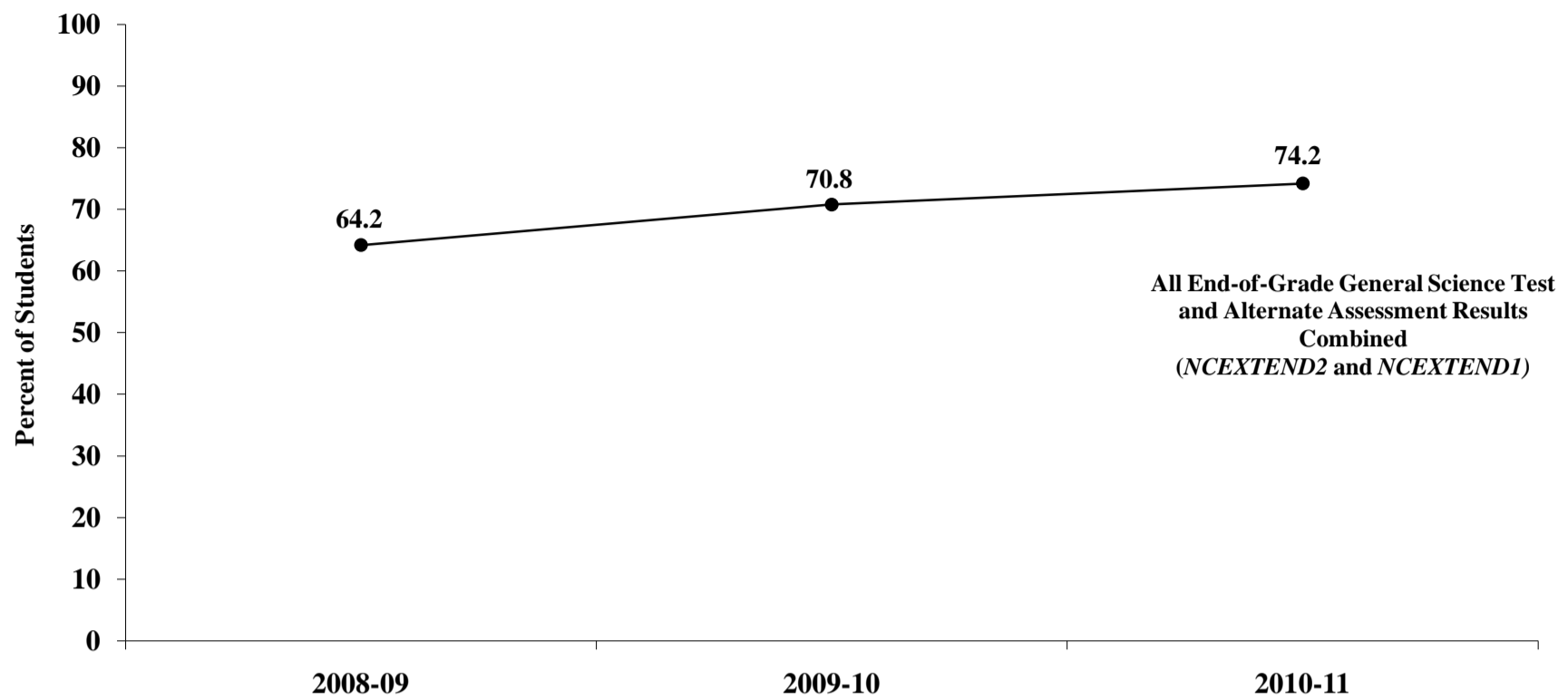

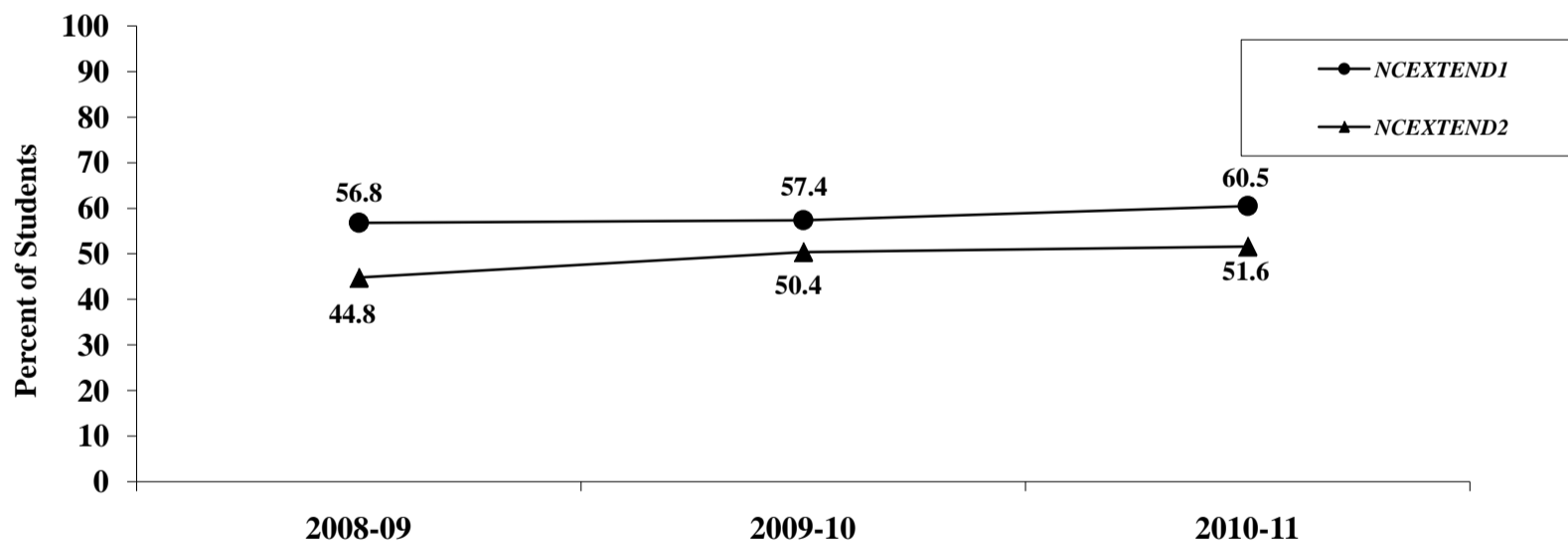

After Retests Grades 5 and 8, with Final Administration Scores**



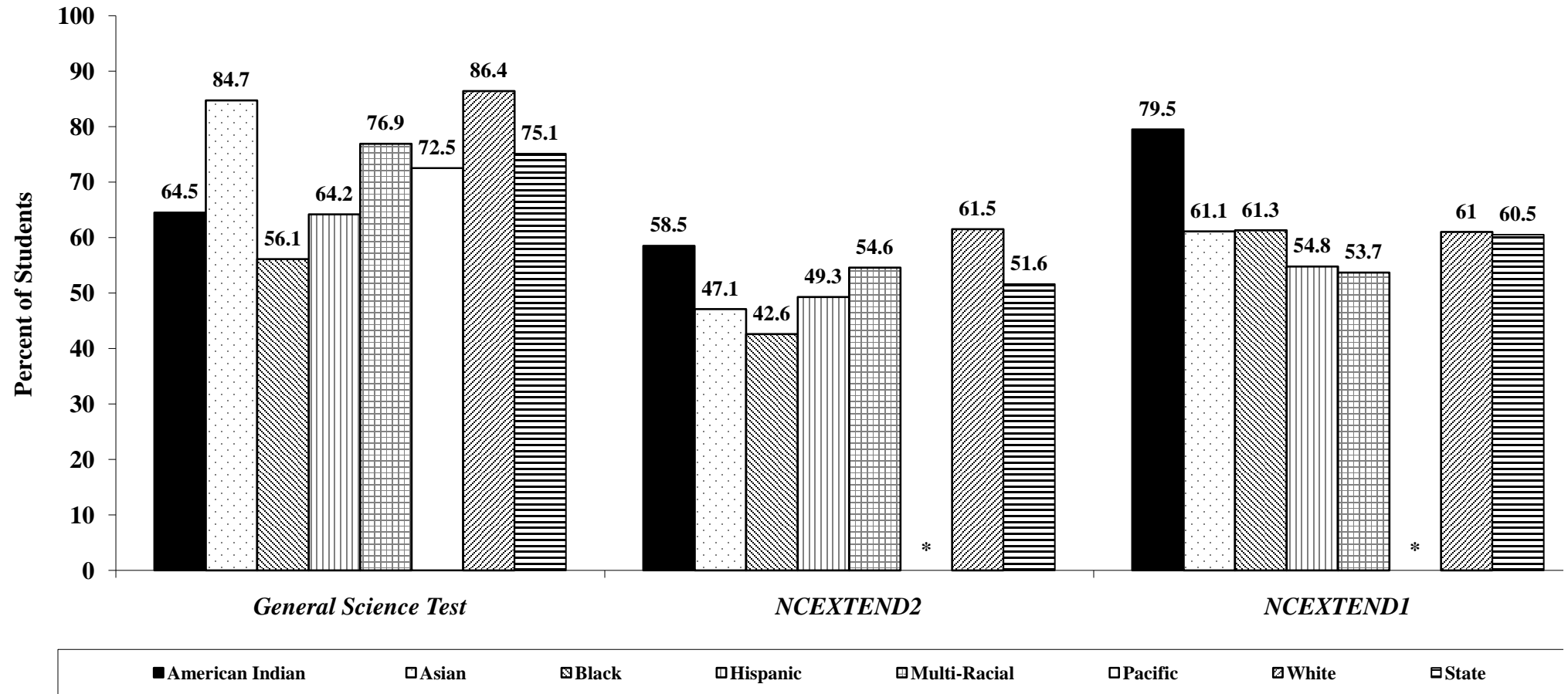

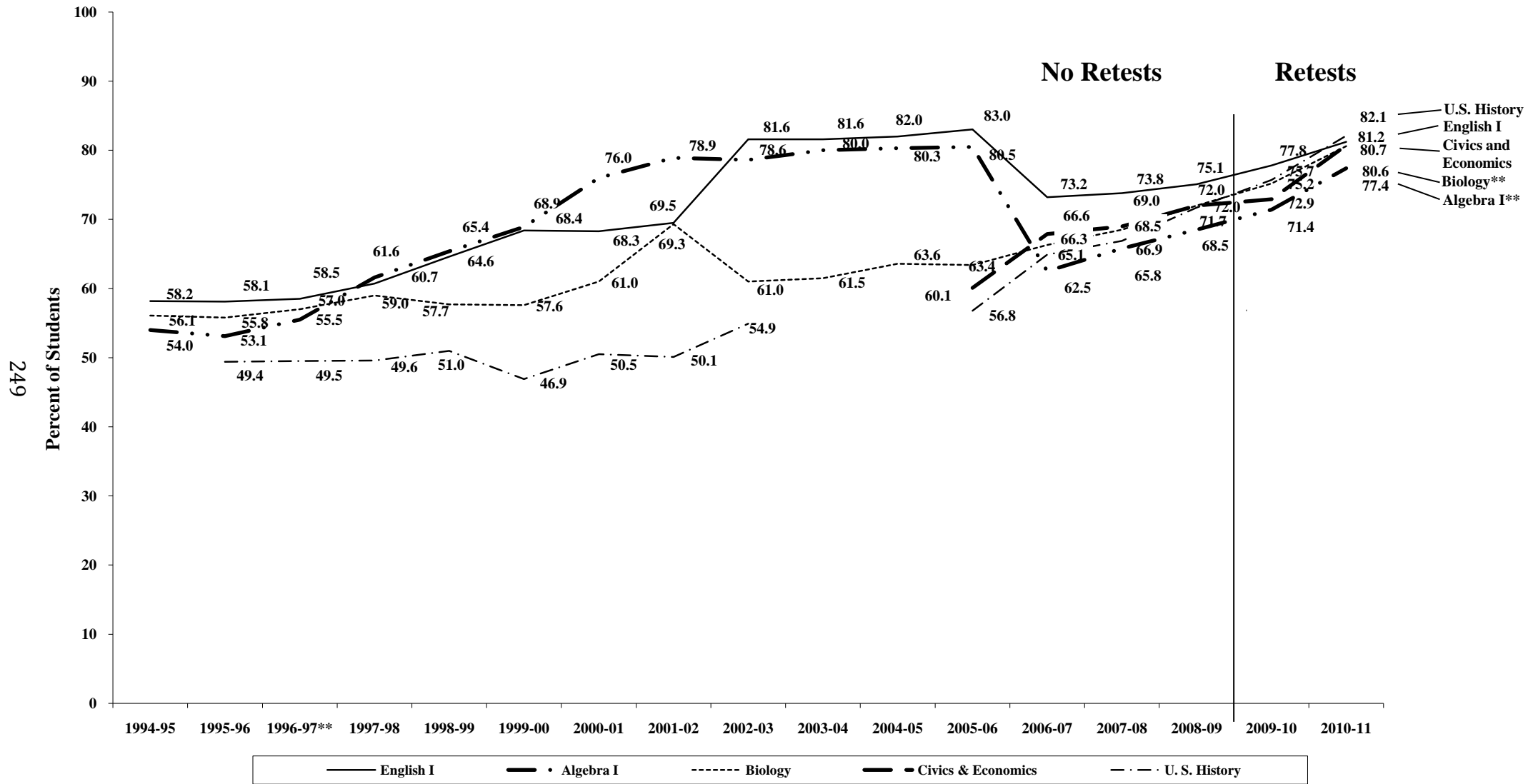
