**Notes**

- (1) All schools within the district must be closed for 8 full days, any 4 years during the last 10 years.
- (2) Without a good cause waiver
- (3) All schools within the district must be closed all or part of the day 8 days, any 4 years during the last 10 years.  
Part of the day is defined as being closed two or more hours
- (4) The Monday closest to August 26
- (5) The Friday closest to June 11
- (6) LEA/CS may request waiver from SBE of up to 5 instructional days
- (7) Waiver only applies to the beginning and end date
- (8) Opening date can be no earlier than the Monday closest to August 19 with a waiver
- (9) For those LEAs attending for 185 instructional days, with three holidays at Christmas each year, under HB834, the calendar will only allow for nine (9) teacher workdays. Otherwise, the calendar must include at least 10 teacher workdays.
