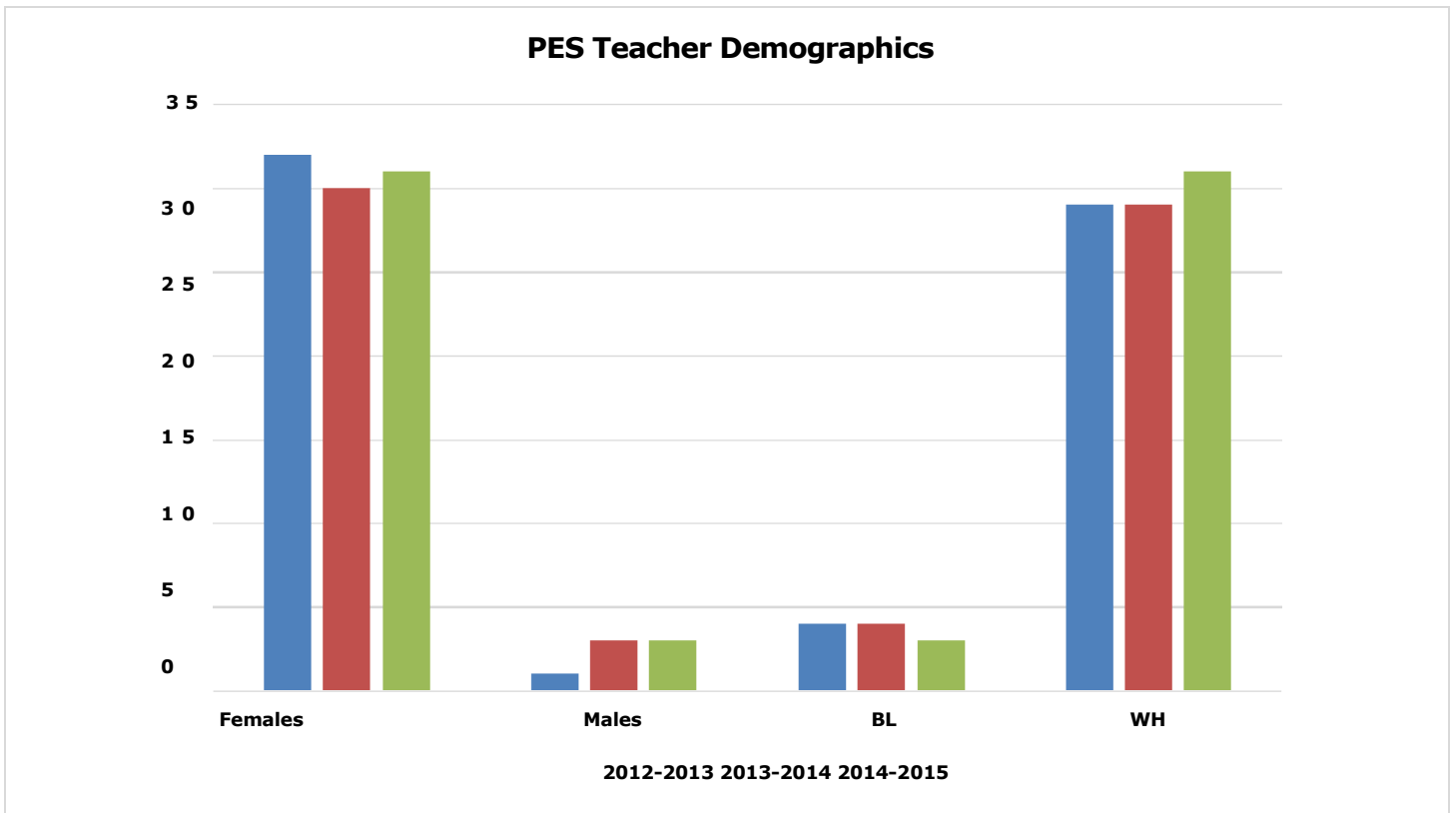

Parkwood Elementary School is a dynamic public school centrally located in the heart of the Northwoods Community in Jacksonville. Since the school opened its doors in August of 1969, significant improvements have occurred on the campus to meet the continuously changing needs of its diverse students. Most recently, in March of 2009, funded through a bond referendum, Parkwood opened a multi-purpose building which has an Art, Music, P.E., and Spanish room, along with two regular classrooms and one lab room. Parkwood Elementary has added, through the donations of the local Civitan Club, a Sensory Room for any student who requires it.

Faculty and Staff

Parkwood has a strong instructional team of energetic teachers and resourceful administrators who are focused on the task of school improvement. Currently, Parkwood employs 63 staff members, 42 of these are licensed and 21 are classified staff. We have a Principal and Assistant Principal, one school counselor, one part time nurse, one part time school social worker, one part time school psychologist, three office support employees, one media specialist, one speech pathologist, one part time Information Technology Technician, three exceptional needs teachers, and one part time Academically Gifted Teacher. We have 25 regular education teachers and four enrichment teachers, including a Spanish teacher. Of the 42 licensed staff, 16 hold a Master's degree, 8 are Nationally Board Certified, and 6 are AIG Certified.

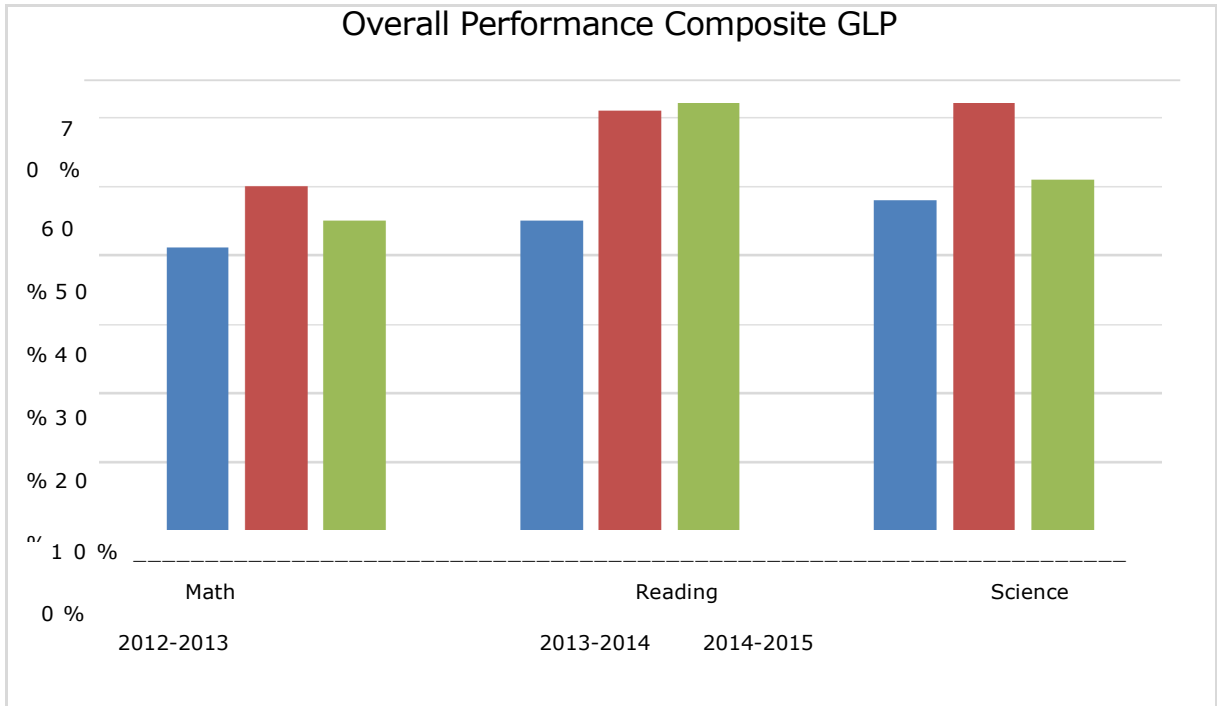
We also have several Coaches that work with our school. These coaches serve at least 2 schools in the county. Our coaches are: EC Coach, Instructional Coach, Digital Learning Teacher and Literacy Coach. These individuals serve to improve our instructional services and to assist teachers in their classrooms.



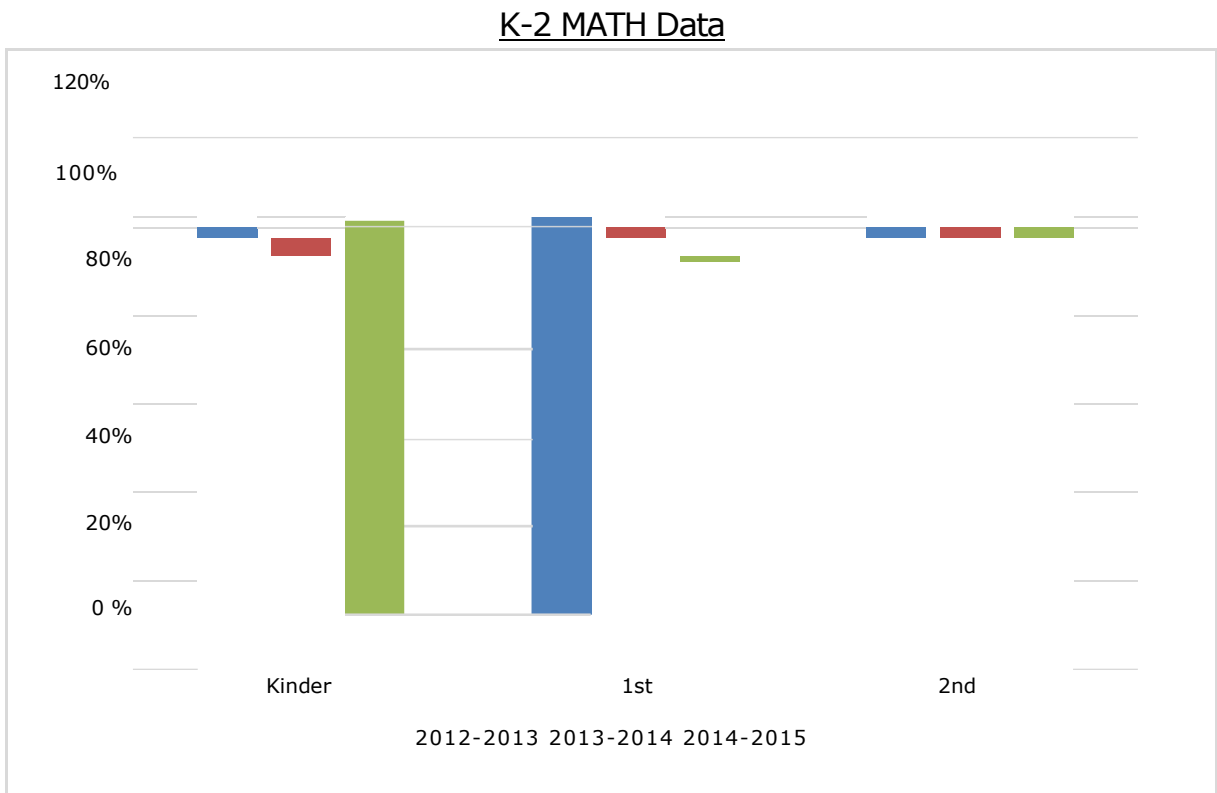
Student Performance Data

The state of North Carolina administers an end-of-grade assessment (EOG) in grades three, four and five at the elementary school level. The end-of-grade assessments include testing in math and reading in grades three, four and five. Fifth grade also has a Science EOG. Teachers analyze the EOG data for the students in their classroom in order to enhance student achievement or to remediate areas of needed improvement. During the 2013-14 school year, the state changed from four levels of achievement to five levels of achievement. Students who score a Level 3, 4, or 5 are considered to be proficient at their current grade level. During the 2014-15 school year, the state discontinued the use of an Alternative Assessment for students with Exceptional Needs, the Extend 2, which was a shorter version of the grade level assessment. Parkwood has historically met student growth and scored at or above state and local scores. During the 2014-15 school year, Parkwood did not meet expected growth for our students. Below are graphs of the past three years of achievement data for Grades 3 -5, State EOGs and for Grade K - 2.

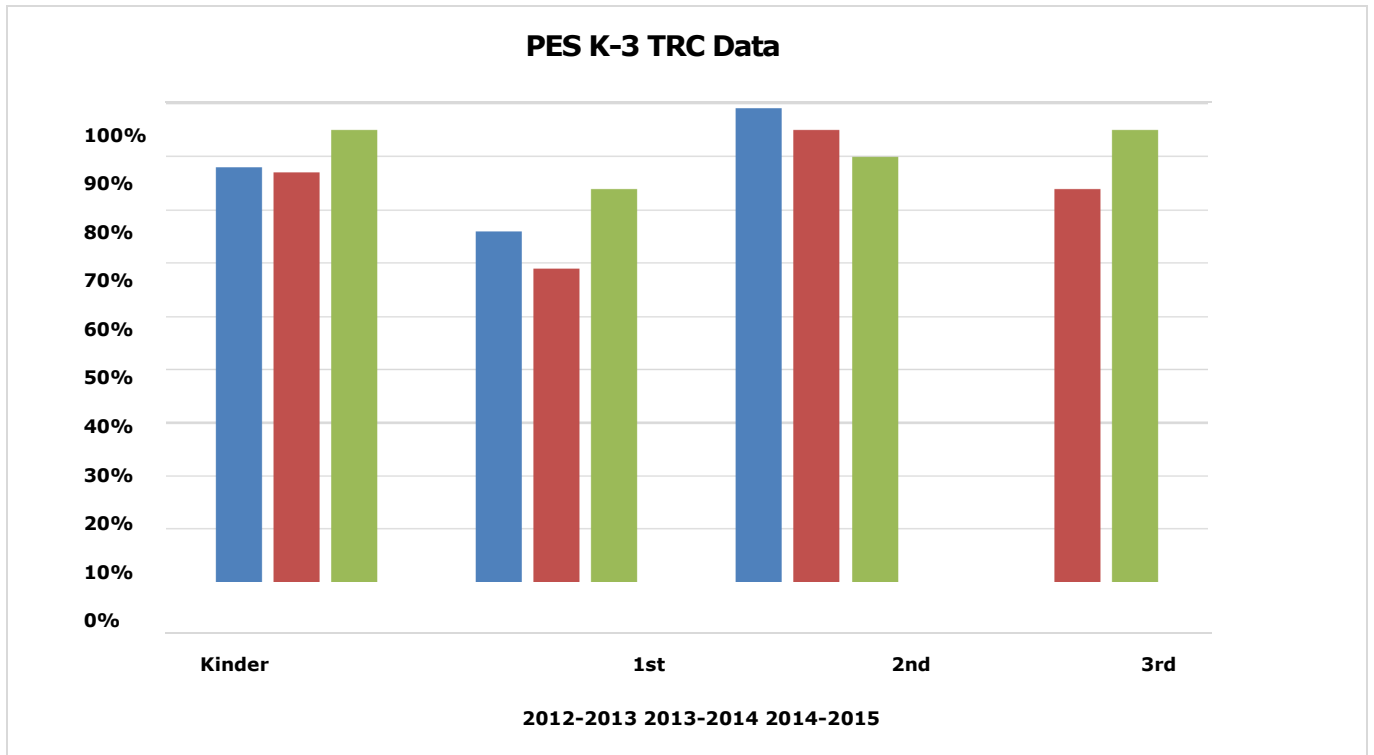
2012-2015 Overall Performance

2012-2015 K-3 TRC Data

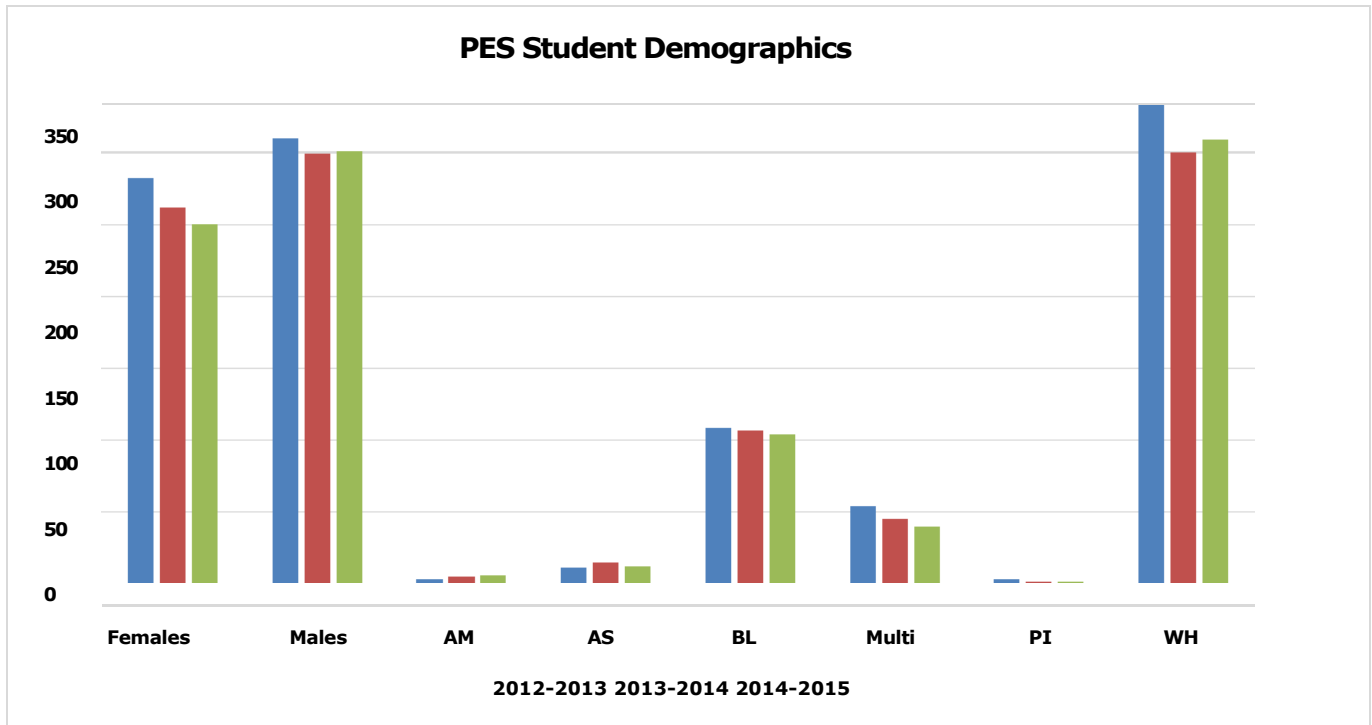


During the 2012-2013 school year, Parkwood Elementary met 26 out of 27 of its Annual Measurable Objectives. In the 2013-2014 school year, 28 out of 31 targets were met. 21 out of 29 targets were met in 2014-2015. Trend data suggests that our black students and students with disabilities perform below other subgroups. Math has, historically, been an area of continued concern, with lower performance at grade level for all subgroups. The gap between students achieving College and Career Ready (Achievement levels 4 and 5) and Grade Level Proficiency (Achievement levels 3, 4, and 5) was reduced in the 2014-2015 school year. In the 2013-14, Parkwood Elementary exceeded state established growth measures. Parkwood did not meet expected growth in 2014-2015.

2012-2015 Student Demographics



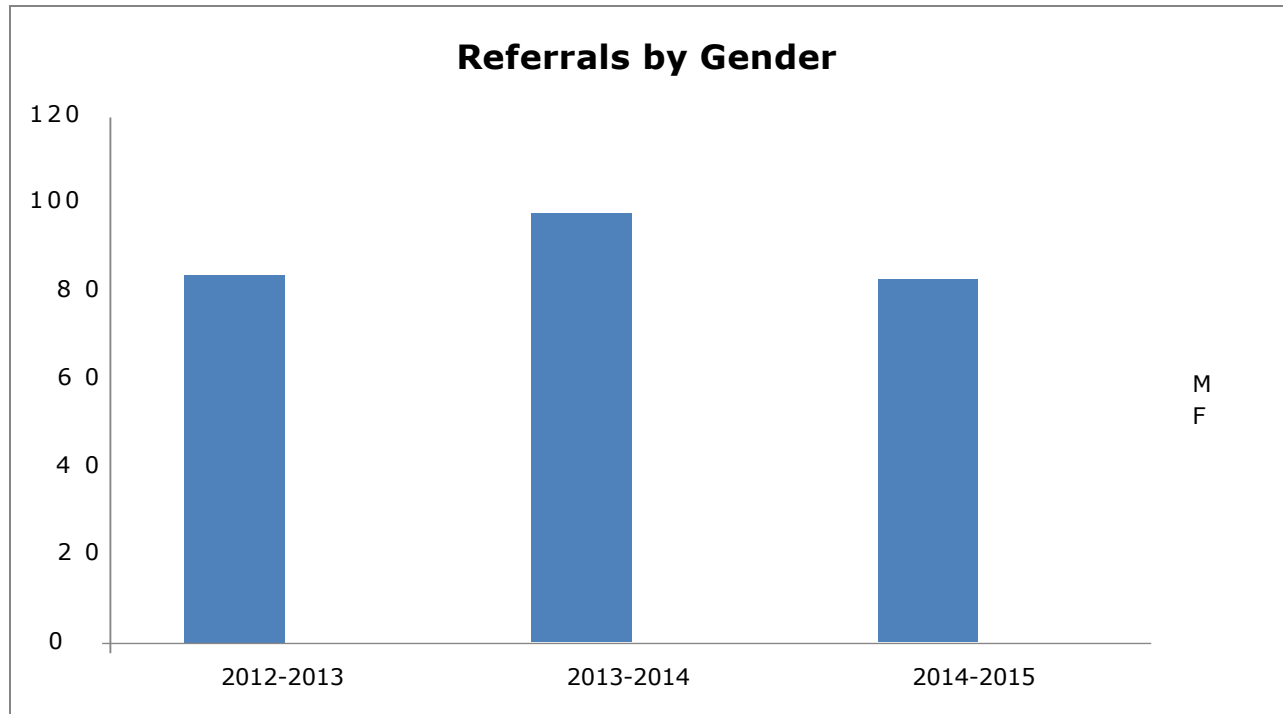

School Characteristics

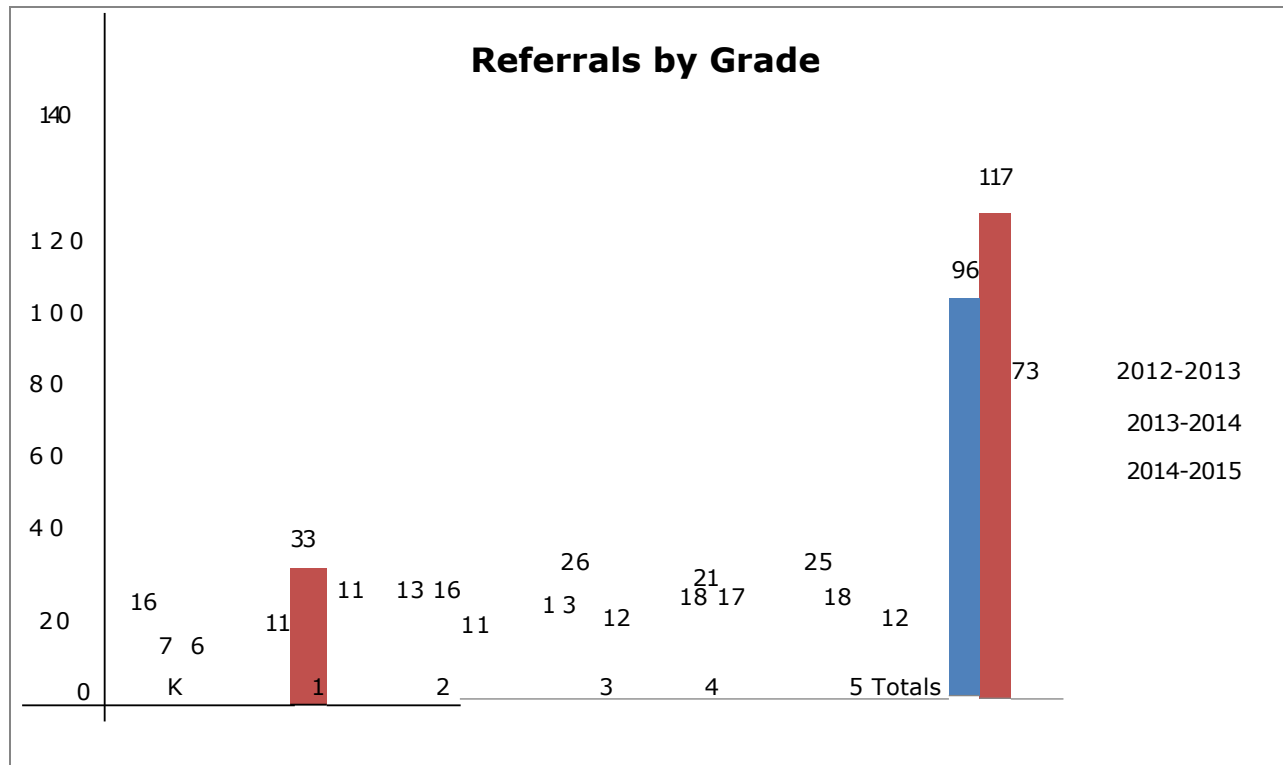
Parkwood Elementary School has an effective volunteer and Parent-Teacher Organization. These two areas assist in bringing the home and school together as partners in education by creating a successful two-way communication system and a greater understanding of educational needs and goals. To assist in this effort, Parkwood utilizes various avenues of communication to keep parents and the community abreast of the changing needs of its students and a clear focus on the school's vision for success. Examples of these include parent nights, teacher web pages, monthly newsletters, and the school's website.

In order to maintain a positive atmosphere on campus and minimal office referrals for discipline, we follow the "Safe and Civil Schools" initiative. This program provides common expectations for movement around campus, in the cafeteria, the playground, and in the restroom. Students begin each day stating our Guidelines for Success, which are from an acronym of our mascot – Pandas. P- Positive Attitude, A – Act Responsibly, N - Never Say Never, D- Do Your Best, A – Accept Change and S – Support Others.
